Applicable Organisations

To receive a reduced registration rate for their animal, the owner of the animal needs to be a member of one of the applicable organisations with which the animal is also registered.

Approved dog obedience training

There are four organisations whose qualified trainers who can issue certificates that entitle you to a discounted registration.

1. DOGS Victoria
2. Australian Association of Professional Dog Trainers Inc.
3. Four Paws K9 Training
4. Kintala Dog Club Association Inc.

State Government Levy

A state Government levy of \$4.40 for every dog and cat is included in your pet's registration fee. This levy is primarily used to fund responsible pet ownership educational programs.

Concession

For persons eligible under the State *Concessions Act 2004* (pension card concession card. War widow entitlements or TPI entitlements) 50% concession rate applies for both maximum and reduced fees unless specified. This does not include Health Care Card Holders. Please present your card to receive this concession. Please note that concession rates are not applicable to declared dangerous and menacing dogs.

Declared Dogs

If Council declares a dog to be dangerous or menacing, there are certain rules that must be complied with in accordance with the Regulations under the *Domestic Animals Act 1994*. More information can be found on

Working Dog Status

You are eligible for reduced registration fees if your dog is kept for working stock and you are a primary producer. To be eligible the dog must be used primarily for the purpose of droving, tending, working or protecting stock. Proof required.

All animals over the age of three months must be registered and thereafter the registration must be renewed.

All new animals must be microchipped prior to being registered.

Initial registration for adopted cats or dogs from an approved shelter or under 12 weeks is free.

The following additional requirements and conditions must be taken into consideration prior to completing the registration application form.

- Proof of sterilisation must be presented for the reduced fee when claiming the fee for the first time.
- Satisfactory evidence may be required to claim the reduced fee in respect of an animal's age.
- A Primary Producers Certificate or other satisfactory evidence is required in respect of dogs kept for working stock.
- Persons claiming compliance with approved obedience training must produce satisfactory evidence.
- Persons claiming approved organisation registration must produce current membership.
- Proof is required for animals that are permanently identified in the prescribed manner (micro-chipped).
- Lifetime registration tags will be issued and must be worn on the animal's collar.
- No more than two dogs and/or two cats can be kept in a residential area without a permit and the number of animals in other areas is defined under the Planning Scheme.
